

File Warranty Claim

The File Warranty Claim process allows customers and agency representatives to submit warranty claims to ADP through the ADP Inside portal. The user will be guided through a series of screens that will ask for information regarding the unit, installation, and the issue that caused the unit to fail.

1. There are two methods to navigate to File Warranty Claim:

From the ADP Inside home screen click on the "File Warranty Claim" box.

Error Messages

Incorrect information

1. If the purchase part is out of warranty, then you will receive the error message below.

Purchase Part is not covered under the Warranty.

2. If the serial number is out of warranty, then you will receive the error message below.
